

### 2020 Highlights

- NFLT working with York County Forever (YCF), and the South Carolina Conservation Bank, the Stuck family placed a donation of a 2,700 acre conservation easement (CE) southwest of York. Debbie and her husband Bob have now placed easements on 3,850 acres of beautiful countryside. The protected acres help to form a greenbelt around York that preserves the southern approach to the City. This is NFLT's largest conservation easement ever and the largest CE in the State this year.
- In a historic day for our community, NFLT and York County placed a Conservation Easement on the 1,900-acre Riverbend Property. Under the easement, 1,700 acres will be protected in perpetuity. The agreement limits development of the property to recreation and interpretation. Approximately 200 acres are available for future development by the County. It borders the Catawba River for over five miles. The new Riverbend Park, features primary forests, seasonal wetlands, ponds, enormous pines, and expansive meadows.
- **Dorsey Patrick** has placed a conservation easement on her 24 acres of land located in the shadow of Nannys Mountain. Plans for a 5-acre Dog Park will be part of this conservation easement.
