
Nick Wimmer is the executive director and cofounder of Camp Canaan. Nick and his wife Tiffany have four children.


Welcoming Our New Chairman

Three New Conservation Easements Underway

York County Forever have voted to place a 248 tract into a conservation easement. The property is located down the road from Historic Brattonsville and is owned by York County native, Pat Williamson. This tract is in close proximity to several other conservation easements in McConnells.

Our second easement underway is a 30 acre property in Union Co. in North Carolina. We have been asked by Catawba Lands Conservancy to hold the conservation easement on the donated property.

Furthermore, we are working with Crescent Communities to secure a 15 acre easement off of Allison Creek Rd.



mall Organization, Big Impact

2019 will be NFLT's 30th anniversary and to date NFLT protects 11,279.78 acres! Our grasp extends beyond York County, we have easements on properties in Beaufort, Chester, Lancaster, Mecklenburg, and Union Counties. NFLT is actively looking for opportunities to preserve our scenic heritage and improve the ecological health of our region.

During the last year, our ED, Brittnay Brown, noticed hundreds of tires in Sugar Creek. The Fort Mill Times wrote on this story a couple of times

now and with their community reach we received overwhelming support from the community. There were local businesses willing to donate food and drinks, people willing to lend their tools and equipment and partner organizations supporting the clean-up. Although we had to cancel three of the five clean-ups due to weather, we have removed 135 tires from Sugar Creek. We would like to thank York County Waste and Recycling for their help with tire disposal. Also, we would like to thank the 7th and 8th grade students of Co-

menius School for Creative Leadership for their hard work. These students removed 64 tires in just a couple of hours! There are several hundred more tires to remove and we are planning our next clean-up for May 12th. Please add us on Facebook to receive updates about our volunteering opportunities.

Sugar Creek receives majority of the runoff from Charlotte and Fort Mill so even a little rain can cause the creek to rise six feet or more. We need volunteers and funding! Please help any way you can.

An Exciting Year Ahead

NFLT is elated to announce the first annual RACE FOR GREEN-SPACE. We will be hosting a 5K at the Piedmont Medical Center Trail in Fall 2018. The Race for Green-space allows us to reach out to the community and promote healthy living, sustainable natural resource practices, and the necessity for balance between development and greenspace. All proceeds for the Race for Greenspace will go to NFLT in order to fund our conservation goals for our Region. Please spread the word and check the

We will be unveiling our new website this Spring! With the help of our sponsor, InConcert Web Solutions, we are upgrading and redesigning our webpage. The new website will give us the ability to update our information with ease and become more user friendly.

In other news, we are working with the City of Rock Hill on an archaeological dig at our Civil

War Battery site. NFLT owns the .3 acre battery site that was donated in 1999. This site was a civil war battery for the protection of the railroad trestle across the Catawba River. This site is the highest point along this portion of the river, with an elevation of 550 feet. The dugout area where the battery was located is still visible today, however, to preserve the site we keep it closed off to the public.

Newest Nation Ford Greenway Segment on Catawba

We have officially begun construction on a 2.3 mile trail that will run from the York County Culture and Heritage Museum property (north of I-77) in Masons Bend and extend through the Scott Family property and continue under Hwy 21 to the existing Piedmont Medical Center Trail at Riverwalk. This trail

has proven to be more challenging than anticipated, however, we are grateful for the South Carolina PRT and Carolina Thread Trail for their help and funding. This will also become the newest addition to the CTT and will create over seven miles of continuous trail. The trail follows under 1-77 and

under Hwy 21 and provides hikers and bikers with an overlook of the Catawba River. We are hopeful that the trail will open by mid Spring 2018.


NFLT Office is Moving Again
